IDS Telcom Corp. ("Applicant" or "Company"), by its attorney, pursuant to Section 1220-4-1-.08(1)(a) hereby respectfully requests that the Tennessee Regulatory Authority ("TRA"), approve the Company's use of the assumed name "Cleartel Telecommunications".

Upon approval of the use of the assumed name, the Company will amend the title page of its tariffs on file with the Tennessee Regulatory Authority accordingly.

The Company further submits the following:

- 1. The Company was granted authority by the TRA's June 30, 2005 Order in Docket No. 05-00048 to acquire certain assets of IDS Telcom, LLC ("Old IDS"), and thereafter consummated said transaction. The Company maintains its headquarters at 2855 South Congress, Delray Beach, FL 33445.
- 2. On June 14, 2006, pursuant to T.C.A § 48-14-103, the Company filed an Application for Registration of Assumed Corporation Name with the Tennessee Secretary of State to use the assumed name "Cleartel Telecommunications" for purposes of aligning the Company's identity more closely with that of its parent company, Cleartel Communications, Inc. A file-stamped copy of that application and the accompanying filing acknowledgement from the Secretary of State is attached hereto as **Exhibit A**.
- 3. The Company has amended Irrevocable Standby Letter of Credit Number 68005535 obtained pursuant to T.C.A. § 65-4-125 in favor of the TRA with Bank of America to reflect usage of the assumed name. That amendment is enclosed as **Exhibit B**.

4. The Company intends to notify its customers of the use of the assumed name by utilizing a bill message during its October and November billing cycles (customers are billed on a staggered basis). A copy of the bill message is attached as **Exhibit C**. The assumed name will be used generally on a going forward basis, rather than on a service specific basis. The Company's corporate name will continue to be used, however, in interaction with existing customers for the convenience of the same.
