RESPONSE OF CHATTANOOGA MANUFACTURERS ASSOCIATION
TO MOTION TO COMPEL

The Chattanooga Manufacturer Association (“CMA”) submits the following response to the “Motion to Compel” filed April 10, 2007 by Tennessee American Water Company (“TAWC”).

TAWC complains (at 3) that they did not get the following information:

1. A list of prior proceeding sin which Mike Gorman testified;
2. A list of Gorman’s publications; and
3. All documents relating to Gorman’s employment in this case.

CMA responds as follows:

1. CMA has previously provided a list of those dockets in which Mr. Gorman has testified over the last five years. That list is attached to t his response.
2. Mr. Gorman has not authored or co-authored any publications.
3. There are no documents concerning Mr. Gorman’s employment in this case.

There is only a verbal agreement between Mr. Gorman and CMA.

TAWC also complains that CMA did not provide all the information requested by TAWC “addressing the impact of the cost of water” (motion at 2) on two CMA companies, R. L.

Stowe Mills and Koch Foods. (Representatives of both companies have filed testimony opposing TAWC's proposed rate increase.)

TAWC requested detailed financial documents from each company, including balance sheets, profit and loss statements, "detailed complete information on the cost structures" of each company and information on the cost of other taxes and utilities paid by these companies.

CMA objects to those questions as unnecessarily burdensome, but in the effort to be responsive, CMA provided information about the relative utility costs paid by both companies so that TAWC could evaluate the relative "impact of the cost of water" on each company. CMA also provided overall operations costs for R. L. Stowe Mills. This information gives TAWC the comparative information it needs to understand the relative significance of the cost of water to each company's operations. Moreover, each company's witness will be subject to cross-examination at the hearing. These corporate witnesses should not be required to reveal detailed profit and loss information about their companies in order to be able to testify against TAWC's proposed 20% increase in water rates.

For those reasons the Motion to Compel should be denied.
