Lightyear Network Solutions, LLC, First Communications, LLC, and First Communications, Inc., (collectively, "Petitioners"), through their undersigned counsel, hereby respond to the Tennessee Regulatory Authority's Data Request No. 1, dated December 5, 2006.

1. Have the petitioners filed similar petitions or notices in other states? If so, provide a listing of states and actions taken.

Petitioners have requested approval for the proposed transaction from the following states: California, Colorado, Georgia, Hawaii, Indiana, Louisiana, Minnesota, Mississippi, Missouri, Nebraska, New Jersey, New York, Ohio, Pennsylvania, Tennessee, Texas, Utah, Virginia, West Virginia, and Wyoming. All of these requests for approval are pending.

Petitioners have also filed notice of the proposed transaction in the following states: Alabama, Arizona, Arkansas, Connecticut, Delaware, Florida, Idaho, Illinois, Iowa, Kansas, Kentucky, Maine, Maryland, Massachusetts, Michigan, Montana, Nevada, New Hampshire, New Mexico, North Carolina, North Dakota, Oklahoma, Oregon, Rhode Island, South Carolina, South Dakota, Vermont, Washington, and Wisconsin.

Petitioners filed an application with the FCC on December 6, 2006. Both domestic and international docket number approvals are currently pending. The FCC's International Bureau assigned File No. ITC-T/C-20061207-00550 to the application. The FCC's Wireline Competition Bureau has not yet assigned a docket number to the application.
