PETITION FOR APPROVAL OF AMENDMENT TO THE RESALE AGREEMENT NEGOTIATED BETWEEN BELLSOUTH TELECOMMUNICATIONS, INC. AND EXPRESS CONNECTION, LLC PURSUANT TO THE TELECOMMUNICATIONS ACT OF 1996

COME NOW, Express Connection, LLC ("Express Connection") and BellSouth Telecommunications, Inc., ("BellSouth"), and file this request for approval of the Amendment to the Resale Agreement dated February 3, 2005 (the "Amendment") negotiated between the two companies pursuant to Sections 251 and 252 of the Telecommunications Act of 1996, (the "Act"). In support of their request, Express Connection and BellSouth state the following:

- 1. Express Connection and BellSouth have successfully negotiated an agreement providing for the resale of BellSouth's telecommunications services to Express Connection. The Resale Agreement was approved by the Tennessee Regulatory Authority ("TRA") on May 16, 2005.
- 2. The parties have recently negotiated an amendment to the Resale Agreement which modifies the Notice provision in the Agreement. A copy of the Amendment is attached hereto and incorporated herein by reference.
- 3. Pursuant to Section 252(e) of the Telecommunications Act of 1996, Express Connection and BellSouth are submitting their Amendment to the TRA for its consideration and approval.

4. In accordance with Section 252(e) of the Act, the TRA is charged with approving or rejecting the negotiated Amendment between Express Connection and BellSouth within 90 days of its submission. The Act provides that the TRA may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement with the public interest, convenience and necessity.

5. Express Connection and BellSouth aver that the Amendment is consistent with the standards for approval.

6. Pursuant to 47 USC Section 252(i) and 47 C.F.R. Section 51.809, BellSouth shall make available the entire Interconnection Agreement filed and approved pursuant to 47 USC Section 252.

Express Connection and BellSouth respectfully request that the TRA approve the Amendment negotiated between the parties.



WHEREAS, BellSouth and Express Connection entered into the Agreement on February 3, 2005, and:
