SUBJECT: Chattanooga Gas Company (CGC), ACA and IPA Filings – Extension of 180-day audit period to June 25, 2007

The six-month deadline for the completion and approval of the TRA Staff's audits of these dockets was previously extended to June 11, 2007. The June 11 conference has now been cancelled. Therefore, Staff has requested a fourteen-day extension of this deadline to the June 25, 2007 Authority Conference. TRA Rule 1220-4-7-.03(2) provides for an extension of the 180-day notification by mutual consent of both the Company and the TRA Staff.

On May 18, 2007, Staff contacted the Company to request the above extension. Archie Hickerson, Director of Regulatory Affairs for CGC, responded that the Company did not object to the requested extension. See attached email from the Company.
