Dear Chairman Kyle:

I am pleased to inform you that the merger between AT&T Inc. and BellSouth Corporation closed on December 29, 2006, at which time BellSouth Corporation became a wholly-owned, first-tier subsidiary of AT&T Inc.

As a result of the merger at the holding company level, BellSouth Telecommunications, Inc. will adopt the AT&T brand name for its products and services. The transition from the use of the BellSouth brand name to the AT&T brand name is expected to occur over the next few months.

To that end, pursuant to Authority Rule 1220-4-1-.08, BellSouth Telecommunications, Inc. ("BellSouth") hereby respectfully notifies the Authority that it will use the d/b/a names "AT&T Tennessee" and "AT&T Southeast." While BellSouth Telecommunications, Inc. will remain the corporate entity providing local service in this State, BellSouth will do business under the d/b/a names of "AT&T Tennessee" and "AT&T Southeast." BellSouth is seeking approval for two d/b/a names so that one can be used for single state functions and/or products and services and one that can be used to describe functions, activities and/or products and services that are uniform through the nine-state footprint.

Attached to this notice are the following:


- (1) A copy of the papers that will be filed with the Secretary of State evidencing the d/b/a names "AT&T Tennessee" and "AT&T Southeast;"
- (2) A copy of the proposed customer notice for Authority approval.

Pursuant to T.C.A. § 65-4-125, BellSouth is not required to post a bond, based upon its ownership of more than \$5,000,000 in equipment/facilities in Tennessee.

With regard to the tariffs, BellSouth is filing, concurrent with this d/b/a filing, new tariff cover pages reflecting the names under which BellSouth will be doing business in Tennessee.

The address of the post-merger company and the company contact information on file with the Authority remains unaffected by this d/b/a notice.


