Following are instructions for navigating the website:



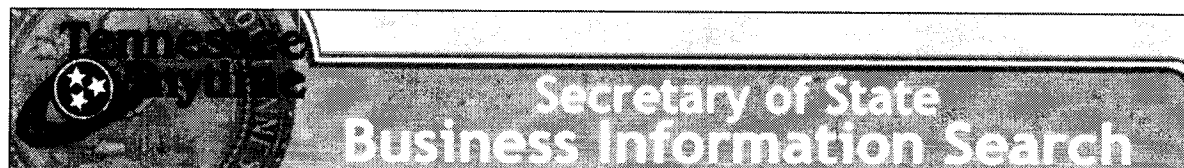
