
Dear Ms. Kyle:

COMPETING LOCAL TELECOMMUNICATIONS SERVICES



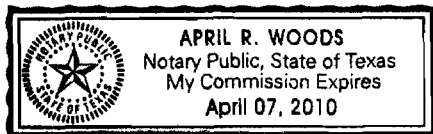


