**FIRST DISCOVERY REQUEST OF ATMOS ENERGY CORPORATION
TO ATMOS INTERVENTION GROUP**

Atmos Energy Corporation (Atmos) respectfully serves these discovery requests on Atmos Intervention Group (AIG). Atmos also has submitted a separate set of discovery requests directed to all parties, and Atmos requests that AIG answer those as well.

1. Please identify all of the members of AIG.

2. For each member of AIG that has purchased gas or any type of gas service (including, without limitation, transportation service) from Atmos in Tennessee in the past 24 months, provide the following information:

- (a) Provide the address of each location that has purchased gas or gas service from Atmos;
- (b) Separately for each such location, identify the type(s) of gas service (by Atmos tariff number and name) under which each location has purchased gas or gas service from Atmos in the past 24 months;
- (c) Separately for each such location, identify each other entity from which gas or gas-related marketing or other services have been purchased in the past 24 months;

- (d) Produce a copy of all contracts for gas or gas-related marketing or other services that have been in force during any part of the last 24 months;
- (e) Describe and explain all of the contractual, economic and other terms under which each such location has purchased gas or gas-related marketing or other services in the past 24 months.

3. For the members of AIG who are (or were at the time) Atmos transportation customers, in the past 24 months has any such member's daily gas usage deviated from its nomination by more than 10%? If so, then separately for each such occasion explain why this occurred.
