## ORDER ON PROCEDURAL SCHEDULE

This docket came before the Hearing Officer at a Status Conference held on December 13, 2007, to consider, to the extent possible, the scheduling of proceedings to completion. On January 16, 2008, in the *Order on Motion to Join Atmos Energy Marketing, LLC and Procedural Schedule*, I set forth a proposed procedural schedule and required Atmos Energy Corporation ("AEC") to "file on behalf of all parties by 2:00 p.m. on Tuesday, January 22, 2008, a statement confirming that all parties agree to the above, proposed procedural schedule or proposing modifications thereto." On January 22, 2008, AEC filed a letter and stated that the parties had met and agreed to certain modifications of the proposed procedural schedule. Specifically, the parties agree to the following schedule:

I find that the parties proposed modifications, with one exception, are acceptable. Specifically, I am unavailable on March 11, 2008, for a Pre-Hearing Conference; therefore, it will have to be scheduled for a different date.

- 1. The procedural schedule proposed by the parties in the January 22, 2008, letter is adopted with the exception of the date for the Pre-Hearing Conference.
- 2. Each party shall file by **Wednesday**, **January 30**, **2008**, a statement as to the party's availability for a Pre-Hearing Conference on March 12, 13, 25 and 26, 2008. Each party should also state whether its availability on a particular day is limited to a specific time period during the day.
