SUPPLEMENT

Global Tel*Link Corporation ("GTL" or "Petitioner"), through its undersigned counsel, hereby supplements its Petition filed on January 19, 2007 to reflect an increase in the aggregate amount of the proposed Transactions. Specifically, the aggregate amount of the Transaction may be increased to as high as \$250 million rather than the \$220 million described in the Petition.
