SUPPLEMENT

Global Tel*Link Corporation (“GTL” or “Petitioner”), through its undersigned counsel, hereby supplements its Petition filed on January 19, 2007 to reflect an increase in the aggregate amount of the proposed Transactions. Specifically, the aggregate amount of the Transaction may be increased to as high as \$250 million rather than the \$220 million described in the Petition. Although the aggregate amount may increase, the Transaction will continue to be comprised of the secured credit facilities and term loan agreements described in the Petition. In addition, and as also set forth in the Petition, GTL will grant a security interest in substantially all of its assets in support of the Transactions. The proceeds from the Transactions, including any increase in the aggregate amount, will be allocated to one or more of the proposed uses described on pages 3-4 of the Petition.

For the reasons stated in the Petition, Petitioner respectfully submits that the public interest, convenience, and necessity would be furthered by a grant of the Petition, as supplemented, on an expedited basis.
