AMENDMENT

Global Tel*Link Corporation ("GTL") and TCG Public Communications, Inc. a/k/a GTL Public Communications, Inc. ("TCG") (GTL and TCG together, "Petitioners"), through their undersigned counsel, hereby amend the Petition filed on January 19, 2007 to add TCG as a Petitioner since it too will be pledging its Tennessee assets as security for the Transactions described in the Petition.¹ TCG's assets in Tennessee are similar to those described in GTL's Response to Data Request No. 1.
