Re: Notification of the Assumption of the Fictitious Name "PAETEC Business Services" by US LEC of Tennessee Inc.

Dear Chairman Kyle:

Pursuant to the Authority's Rule 1220-4-1.08, US LEC of Tennessee Inc. ("US LEC") hereby notifies the Tennessee Regulatory Authority ("Authority") that it is assuming the fictitious name of "PAETEC Business Services" to do business in Tennessee.

US LEC has filed the appropriate documentation with the Secretary of State to qualify to do business under the fictitious name of "PAETEC Business Services." A copy of the Application for Registration of Assumed Corporate Name and the Secretary of State's acknowledgement are included in the attached Exhibit A.

On August 12, 2006, US LEC Corp., the parent corporation of US LEC of Tennessee Inc., and PAETEC Corp., the parent corporation of PAETEC Communications Inc. and PAETEC Communications of Virginia Inc. (collectively "PAETEC"), entered into an Agreement and Plan of Merger under which US LEC Corp. and PAETEC Corp. will merge into wholly-owned subsidiaries of PAETEC Holding Corp. On or about October 26, 2006, the Authority considered and approved the petition which sought the approval of the transfer of control of US LEC Corp. and its wholly owned subsidiaries, including US LEC of Tennessee Inc., which will result upon consummation of the contemplated transaction. See TRA Docket No. 06-00221.

US LEC will begin using the fictitious name in Tennessee upon the closing date of the merger between PAETEC and US LEC. The assumption of the fictitious name of "PAETEC Business Services" will permit PAETEC and US LEC to operate for branding and marketing purposes under one corporate brand of "PAETEC," and will facilitate the integration of US LEC into PAETEC as contemplated by the transaction. The transition from the use of the US LEC brand name to the PAETEC brand name is expected to take place over a period of three to four months after the closing occurs.

The assumption of the fictitious name by US LEC will not change any relationships it has with its current customer. US LEC will notify its customers of the assumption of the PAETEC brand name in a letter to be issued on the day of the merger closing and then as a bill message with invoices issued 30 days and 60 days after the merger closing date.

Under separate cover, US LEC will file the necessary tariff revisions with the Authority to reflect the assumption by US LEC of the fictitious name.

We enclose a duplicate of this letter, the requisite number of copies of the filing, and a self-addressed, post-prepaid envelope and the requisite filing fee of \$25.00. We ask the Authority to date stamp the duplicate of this letter and return it to us in the enclosed envelope provided.
