The proceeds of the loan were used to fund capital projects described in the application. KU elected to issue a ten year loan to lock in historically attractive long-term rates, but avoid the extreme long end of the curve where it has issued several notes recently. The cumulative principal amount of debt issued under the authority granted in this order is \$295 million. There is \$170 million of debt remaining to be issued under the authority granted in this order.

On March 30, 2007, Kentucky Utilities Company d/b/a Old Dominion Power Company ("KU/ODP") borrowed \$75 million from Fidelia Corporation. Pursuant to Ordering Paragraph No. 3 of the Commission's Order for the aforementioned proceeding, KU/ODP filed a Preliminary Report of Action on April 10, 2007. However, KU/ODP inadvertently omitted to file the quarterly report within 60 days after the debt issuance date as stipulated in Ordering Paragraph No. 4 in the aforementioned proceeding. KU/ODP apologizes for this oversight and hereby files an original and three (3) copies of information related to an issuance under said Order.

KU elected to issue a thirty- year loan due to the slope of the yield curve with long-term treasury rates within .30% of short-term rates. The cumulative principal amount of debt issued under the authority granted in this order is \$295 million. There is \$220 million of debt remaining to be issued under the authority granted in this order.
