SUPPLEMENT TO PETITION

On February 15, 2007, Level 3 Communications, LLC ("Level 3 LLC"), Broadwing Communications, LLC ("Broadwing"), TelCove Operations, Inc. ("TelCove"), TelCove of Nashville, L.P. ("TelCove Nashville"), and WilTel Communications, LLC ("WilTel Comm" and collectively, "Petitioners") submitted a Petition to the Tennessee Regulatory Authority ("TRA") requesting approval to participate in a financing arrangement whereby Level 3 Financing, Inc. ("Financing"), the immediate corporate parent of Level 3 LLC, will enter into a Credit Agreement for a total of \$1 billion, and related financial arrangements. Since the time the Petition was filed, the arrangement has been increased to a total of \$1.4 billion, and accordingly, Petitioners submit this request to amend their Petition to cover the full \$1.4 billion of the expanded Credit Agreement.

As discussed in the Petition, Petitioners will pledge assets under the terms of the Credit Agreement arrangement, and accordingly, Petitioners request TRA approval to pledge their assets in Tennessee in support of the increased Credit Agreement. Petitioners emphasize that the pledging of jurisdictional assets described herein will not apply to Petitioners until required

regulatory approval is obtained. In addition, a portion of the proceeds from the Credit Agreement will be advanced to Petitioners for an intercompany demand note.

Petitioners' participation in the increased financing arrangement will not result in a change in Petitioners' management or in its day-to-day operations; nor will it adversely affect Petitioners' current or proposed operations in Tennessee. In fact, the financing arrangement will enable Petitioners to bring services to new markets and allow more consumers to benefit from its competitive services more quickly and efficiently. In addition, the financing arrangement will allow Financing and Petitioners to borrow funds under favorable extended maturity terms and reduced interest expenses.

Petitioners file this Supplement to inform the TRA of the increased Credit Agreement, which is part of the offering described in the pending Petition before the TRA, and to the extent required, request approval of the pledge of assets associated with the arrangement, concurrently with the TRA's approval of the pending Petition.
