BROADVIEW NETWORK HOLDINGS, INC.**

The following application was filed pursuant to section 63.03 of the Commission's rules requesting authority to transfer control of the blanket domestic 214 authorizations held by A.R.C. Networks, Inc., Eureka Telecom, Inc., InfoHighway of Virginia, Inc., and Eureka Telecom of VA, Inc. ("Licensees") from Eureka Broadband Corporation to Broadview Network Holdings, Inc. ("Broadview Holdings").<sup>1</sup> All are U.S. entities, and Licensees provide competitive local exchange and interexchange services in multiple states. Broadview Holdings also provides competitive local exchange and interexchange services in multiple states. The Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(2)(i) of the Commission's rules<sup>2</sup> and that a grant of the application will serve the public interest, convenience, and necessity.

## **GENERAL INFORMATION**

The transfer of control identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer of control application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 CFR §§ 1.415, 1.419, interested parties may file **comments on or before March 20, 2007 and reply comments on or before March 27, 2007.**<sup>3</sup> Unless otherwise notified by the Commission, Applicants are permitted to transfer the assets and related control on the 31<sup>st</sup> day after the date of this notice.<sup>4</sup> Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).
