**APPLICATION FOR DOMESTIC SECTION 214 TRANSFER OF CONTROL OF
FLORIDA DIGITAL NETWORK, INC. D/B/A FDN COMMUNICATIONS AND
SOUTHERN DIGITAL NETWORK, INC. D/B/A FDN COMMUNICATIONS FROM
FDN HOLDINGS, LLC TO NUVOX, INC.**

STREAMLINED PLEADING CYCLE ESTABLISHED

The following application was filed pursuant to section 63.03 of the Commission's rules requesting authority to transfer control of the domestic 214 authorization held by Florida Digital Network, Inc. d/b/a FDN Communications ("FDN") and Southern Digital Network, Inc. d/b/a FDN Communications ("SDN") from FDN Holdings, LLC ("Holdings") to NuVox, Inc. ("NuVox").¹ FDN, a Delaware corporation, provides telecommunications services in Florida. SDN, a Delaware corporation, is a wholly-owned subsidiary of FDN that provides telecommunications services in 8 Southeastern states. FDN is a wholly-owned subsidiary of Holdings, a Delaware limited liability company that does not provide telecommunications services. NuVox, a privately-held Delaware corporation, provides telecommunications services in 16 Midwestern and Southeastern states through its operating subsidiaries. After the transaction is completed, all entities or persons that directly or indirectly own or control 10 percent or greater of the Applicants will be U.S. entities or U.S. citizens.² The Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section

GENERAL INFORMATION

The transfer of control identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer of control application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 CFR §§ 1.415, 1.419, interested parties may file **comments on or before April 24, 2007 and reply comments on or before May 1, 2007.**⁴ Unless otherwise notified by the Commission, Applicants are permitted to transfer the assets and related control on the 31st day after the date of this notice.⁵ Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).

proceeding, filers must submit two additional copies for each additional docket or rulemaking number.
