DOMESTIC SECTION 214 APPLICATION FILED FOR THE TRANSFER OF CONTROL OF STARTEC GLOBAL OPERATING COMPANY FROM STARTEC GLOBAL COMMUNICATIONS CORPORATION TO PLATINUM EQUITY, LLC

STREAMLINED PLEADING CYCLE ESTABLISHED

The following application was filed pursuant to section 63.03 of the Commission's rules requesting authority to transfer control of Startec Global Operating Company ("Startec") from Startec Global Communications Corporation ("SGCC") to Platinum Equity, LLC ("Platinum") (collectively, "Applicants").¹ Startec, a Delaware corporation, is a wholly-owned subsidiary of SGCC, a Delaware corporation that operates as a telecommunications holding company. Startec provides primarily resold long distance services in all states, except Alaska. Platinum, a Delaware limited liability company, indirectly controls two telecommunications carriers, Americatel Corporation and Matrix Telecom, Inc., that provide competitive telecommunications services nationwide. Under the proposed transaction, Platinum will acquire indirect control of Startec after merging with SGCC. The Applicants assert that the proposed transaction is entitled to presumptive streamlined treatment under section 63.03(b)(2)(i) of the Commission's rules² and that a grant of the application will serve the public interest, convenience, and necessity.

GENERAL INFORMATION

The transfer of control identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer of control application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 CFR §§ 1.415, 1.419, interested parties may file **comments on or before May 4, 2007 and reply comments on or before May 11, 2007.**³ Unless otherwise notified by the Commission, Applicants are permitted to transfer the assets a related control on the 31st day after the date of this notice.⁴ Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).
