Dear Chairman Kyle:

Please accept the data responses for Integrated Resource Management, Inc.'s ("IRM") Petition to Amend Its Certificate of Convenience and Necessity to serve an area in Sevier County, Tennessee known as the Landing at Bird's Creek Subdivision as follows:

Data Request No. 1: In the pre-filed testimony, filed with the Petition, Mr. Cox specified that materials and labor would total approximately \$175,000.00. Please provide the estimated amount of contributed capital to IRM once the system is transferred to IRM inclusive of the property/land and any other items that would make up the contributed capital.

RESPONSE: The total amount of contributed capital to be transferred to IRM inclusive of the property/land will be as reflected in the Petitioner's pre-filed testimony—\$175,000.00. IRM will not become the property owner in or around the contemplated system. IRM will only acquire an easement to the subject property for repair and maintenance of the system.

Data Request No. 2: Please provide the proposed wastewater service tariffs for the Landing at Bird's Creek Subdivision. Please include both residential and proposed commercial tariffs.

RESPONSE: A copy of the proposed wastewater service tariff is enclosed herewith as **Exhibit A**.
