**DOMESTIC SECTION 214 APPLICATION FILED FOR THE ACQUISITION OF
ASSETS OF TRINSIC COMMUNICATIONS, INC., TOUCH 1 COMMUNICATIONS,
INC., AND ANY SUCESSOR IN INTEREST, INCLUDING A CHAPTER 7
BANKRUPTCY TRUSTEE, TO MATRIX TELECOM, INC.**

The following application was filed pursuant to section 63.03 of the Commission's rules requesting authority to transfer the assets of Trinsic Communications, Inc. ("Trinsic Communications"), Touch 1 Communications, Inc. ("Touch 1"), and any successor in interest of either, including a Chapter 7 bankruptcy trustee (collectively, "Trinsic"), to Matrix Telecom, Inc. ("Matrix") (together with Trinsic, the "Applicants").¹ Trinsic Communications, a Delaware corporation, and Touch 1, an Alabama corporation, are both wholly-owned subsidiaries of Trinsic, Inc., a Delaware corporation. Trinsic and Touch 1 provide competitive circuit-switched local and long-distance telephony services in 49 states and the District of Columbia. Matrix is a Texas corporation that provides competitive communications services, including local, long distance, and toll-free voice services primarily to enterprise customers throughout the United States. Matrix is an indirect, wholly-owned subsidiary of Platinum Equity, LLC, a Delaware limited liability company owned by Tom T. Gores, a citizen of the United States.

On February 7, 2007, Trinsic and its affiliates filed a petition for relief under Chapter 11 of the United States Bankruptcy Code in the Bankruptcy Court for the Southern District of Alabama ("Bankruptcy Court"). Following a court-supervised auction, Trinsic entered into an Asset Purchase Agreement (APA) to sell assets to Tide Acquisition Corporation ("Tide"), a newly formed subsidiary of Platinum Equity. Tide subsequently assigned rights and obligations under the APA to Matrix. The Applicants assert that the proposed transaction is entitled to

presumptive streamlined treatment under section 63.03(b)(2)(i) of the Commission's rules² and that a grant of the application will serve the public interest, convenience, and necessity.

GENERAL INFORMATION

The transfer of control identified herein has been found, upon initial review, to be acceptable for filing as a streamlined application. The Commission reserves the right to return any transfer of control application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules and policies. Pursuant to section 63.03(a) of the Commission's rules, 47 CFR § 63.03(a), interested parties may file **comments on or before May 10, 2007** and **reply comments on or before May 17, 2007**. Unless otherwise notified by the Commission, Applicants are permitted to transfer the assets a related control on the 31st day after the date of this notice.³ Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS), (2) the Federal Government's eRulemaking Portal, or (3) by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998).
