
RESPONSE TO TENNESSEE REGULATORY AUTHORITY'S
DATA REQUEST NO. 1

Startec Global Operating Company ("Startec" or "Applicant"), by undersigned counsel,
hereby provide the following responses to the Tennessee Regulatory Authority's ("TRA") Data
Request No. 1:

- 1. Is Startec presently providing telecommunications services to any customers in Tennessee? If so, when did Startec start providing telecommunications in Tennessee and how many customers are presently being served?**

ANSWER: Applicant is presently providing resold interexchange telecommunications service to approximately 500 customers in Tennessee, the vast majority of which receive only interstate and international services. Applicant began providing intrastate telecommunications services in Tennessee on December 27, 2006, following the *pro forma* merger of Petitioner with its sister company, Startec Global Licensing Company, which provided telecommunications services in Tennessee pursuant to a certificate prior to the *pro forma* merger. The *pro forma* merger was described in more detail in Startec's Petition filed in Docket No. 07-00082.
