Atmos Energy Corporation respectfully submits this response to the Motion to Compel Atmos Energy Corporation to Answer the First Discovery Requests of the Consumer Advocate and Protection Division, filed on July 10, 2007.

Upon receipt of the CAPD's Motion to Compel, Atmos representatives contacted the CAPD and engaged in discussions regarding the matters raised in the CAPD's Motion to Compel. Atmos is pleased to report that the parties have resolved all of the issues raised in the Motion to Compel.

With respect to discovery requests 130 and 134, the parties have agreed to resolve the issue through the following additional pre-trial procedural steps:

- ▶ On or before September 25, 2007 at 2:00 p.m., the parties will exchange final lists of their hearing exhibits in this matter.
- ▶ On or before September 26, 2007 at 2:00 p.m., the parties will confer and identify any exhibits for which authenticity or admissibility can be stipulated, and, conversely, any exhibits for which admissibility will be contested. This will allow any issues concerning the

admissibility of exhibits to be raised at the September 27, 2007 pre-hearing conference in this matter.
