After initial review of Global Connections Inc. of Tennessee's ("GCI") *Petition for Designation as an Eligible Telecommunications Carrier* ("ETC") additional information is required to continue the review process. A request for the required information was sent to GCI on July 18, 2007 with a response due date of August 16, 2007. The Authority has not received a response from GCI and is resending its request as a second data request. Please respond to the items listed below with the appropriate information.

- 1. List all exchange service areas by name in which GCI is, or is preparing to, provide telecommunications services and is seeking designation as an ETC.
- 2. Indicate the Tennessee exchanges in which GCI is currently providing facilities based services.
- 3. Identify the Tennessee exchanges in which GCI has located its "Class V" switches.
- 4. Provide details outlining the various services/service options and/or innovative services GCI is, or will be, providing to Tennessee consumers.
- 5. List all states in which GCl has applied for ETC designation indicating those states in which the designation has been granted.

- 6. Authority Rule 1220-4-8-.04(3)(b)(5) requires all certificated telecommunications service providers to provide Lifeline and Link Up services in the designated service area(s). GCI does not currently have an approved tariff for these services. Please submit a tariff for Lifeline and Link Up tariffs to review for approval.
- 7. Provide copies of GCI's current and/or proposed advertising for its service offerings and appropriate charges including Lifeline and Link Up services.
- 8. Provide GCI's toll free customer service number(s) for repairs and service connection/cancellation and web site information.

GCI's request to be designated as an Eligible Telecommunications Carrier will be considered sometime after September 18, 2007 with information available at that time.

This information should be provided no later than 2:00 p.m. on September 18, 2007, with reference to Docket No. 07-00106 on the response. In accordance with TRA rules submit either (1) thirteen written copies of your response or (2) four written copies and an electronic version.
