# INTERCONNECTION ADOPTION AGREEMENT AT&T KENTUCKY AND NEXTEL WEST CORPORATION

#### **AGREEMENT**

This Agreement shall be considered effective as of January 7, 2008 ("Effective Date"), and is entered into by and between Nextel West Corporation ("Nextel West"), a Delaware corporation, on behalf of itself and BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky ("AT&T Kentucky"), having an office at 675 W. Peachtree Street, Atlanta, Georgia, 30375, on behalf of itself and its successors and assigns.

WHEREAS, the Telecommunications Act of 1996 (the "Act") was signed into law on February 8, 1996; and

WHEREAS, Nextel West has requested that AT&T Kentucky make available the interconnection agreement in its entirety executed between AT&T Kentucky and Sprint Communications Company Limited Partnership, Sprint Communications Company L.P. and Sprint Spectrum L.P. dated January 1, 2001 for the State of Kentucky ("2001 AT&T Kentucky/Sprint Agreement").

WHEREAS, pursuant to the Kentucky Public Service Commission Orders in Case No. 2007-00255 dated December 18, 2007 and February 18, 2008, for purposes of this Agreement, Nextel West has adopted the 2001 AT&T Kentucky/Sprint Agreement.

NOW, THEREFORE, in consideration of the promises and mutual covenants of this Agreement, Nextel West and AT&T Kentucky hereby agree as follows:

1.
