Dear Chairman Roberson:

By letter dated July 19, 2007, Darlene Stanley, Chief of the Utilities Division of the Tennessee Regulatory Authority, requested that Time Warner Telecom of the Mid-South, LLC ("TWTC") file appropriate tariffs in compliance with the referenced statutory authority. Primarily, TWTC provides services to its customers pursuant to the terms of contracts. By way of discounts to its regular tariffed rates or "special contract" rates, TWTC has implemented its plan to return the benefit of the tax equity payment to its business customers.


Earlier this year, the Authority approved the purchase of the Xspedius operating entities by TWTC and subsequently approved their merger. The records reflect that TWTC received a tax equity payment of \$88,363.64 and the Xspedius entities received \$64,034.69 for a total of \$152,398.33. Accompanying this letter, please find Attachment A, which describes in detail the product or service and the price adjusted rate for monthly recurring charges and nonrecurring charges that are being offered to TWTC business customers during the period October 1, 2007 through September 30, 2008. The total of the discounted rates exceeds the total amount of the equity payment paid to TWTC and Xspedius. The attachment contains commercially sensitive and proprietary information, and, therefore, is being filed herewith under seal as "Confidential and Proprietary."

We anticipate that this material will be deemed responsive to Ms. Stanley's inquiry and will demonstrate TWTC's compliance with Tenn. Code Ann. § 67-6-222. If the Authority needs additional information or further explanation, please do not hesitate to contact the undersigned. I am
