We are in receipt of the attached correspondence regarding STi Prepaid (the "Company"). The Company, along with certain affiliated entities, filed for protection under chapter 11 of the U.S. Bankruptcy Code (the "Code") on September 5, 2012 (Voluntary Petition - United States Bankruptcy Court for the Southern District of New York, Case # 12-13811-mg, Docket #3). On February 7, 2013, the Company ceased operation and transferred substantially all of its assets pursuant to

a sale under Section 363 of the Code (Sale Order - United States Bankruptcy Court for the Southern District of New York, Case # 12-13810-mg, Docket #288).

Accordingly, the Companies are no longer operating as of February 7, 2013
