Dear Ms. Dillon:

On behalf of our clients, AccessLine Holdings, Inc. ("AccessLine"), AccessLine Communications Corporation ("ACC"), and Telanetix, Inc. ("Telanetix") (collectively, the "Applicants"), and in response to a request from Jerry Kettles dated September 13, 2007, we hereby submit an original and thirteen (13) copies of this supplement to the above-referenced application. Specifically, we provide the following requested information:

(1) Applications for both domestic and international authority for the transaction have been filed with the Federal Communications Commission ("FCC") and placed on public notice. See WC Docket 07-192, Public Notice, DA 07-3858 (September 6, 2007); File No. ITC-T/C-20070905-00365, Report TEL-01187S (September 14, 2007). If no action is taken, the domestic approval will be October 7, 2007 and the international approval will be September 28, 2007. In order for the companies to close the transaction on September 14, 2007, the Wireline Competition Bureau and the International Bureau of the FCC granted the companies Special Temporary Authority approving the merger on September 6, 2007 and September 10, 2007 respectively. The STAs are effective for 90 days. The transaction has also been approved by the West



Virginia PSC on September 13, 2007 (Docket 07-1701-T-PC) and by the New York Public Service Commission on September 12, 2007 (Docket 07-C-1045). Applications filed in California, Georgia, Hawaii, Minnesota, Nebraska, Pennsylvania, and Tennessee are pending.

(2) AccessLine Communications Corporation currently has 384 customers in Tennessee.
