
**ORDER GRANTING JOINT REQUEST TO REVISE PROCEDURAL SCHEDULE
CONCERNING THIRD ROUND EXCHANGE OF DISCOVERY**

This matter came before the Hearing Officer upon a joint request of the parties to revise the Procedural Schedule to allow additional time for the exchange of discovery between the parties. On August 5, 2008, via two electronic mail messages, the parties state that they are in agreement to extend the service of third round discovery requests from August 5, 2008 to August 8, 2008. Likewise, the service of third round discovery responses and objections is requested to be extended by agreement from August 26, 2008 to August 29, 2008. In light of the agreement of the parties and to further encourage a spirit of cooperation, the Hearing Officer hereby agrees to and adopts the revised schedule as proposed by the parties. The remainder of the Procedural Schedule will not be altered.
