## CONSUMER ADVOCATE'S MOTION FOR ENTRY OF A PROCEDURAL SCHEDULE

Robert E. Cooper, Jr., the Attorney General and Reporter for the State of Tennessee, through the Consumer Advocate and Protection Division ("Consumer Advocate"), respectfully moves the Authority to set a procedural schedule commensurate with the changed circumstances of this matter.

The hearing in this matter was originally anticipated to take place in late October, 2008 and in particular October 20, 2008. As some of the participants in this matter are involved in a proceeding before the Virginia Commission near this time, the October 20, 2008 date is not available. As a consequence, a new hearing date will need to be set. In addition, the discovery process has taken longer than originally expected. The Consumer Advocate has fewer days between submission of the discovery responses and when rebuttal testimony is due on September 29, 2008. Moreover, because of the summer schedule on other matters, the Consumer Advocate needs additional time to file its rebuttal. Chattanooga Gas Company does not oppose the Consumer Advocate's request for an additional two (2) weeks to file its rebuttal testimony and is agreeable to working with the Consumer Advocate to propose a revised procedural schedule that will appropriately and reasonably adjust the remaining deadlines once a hearing date has been set.

WHEREFORE, the Consumer Advocate respectfully requests that the Authority advise it and Chattanooga Gas Company of the possible new date(s) for the hearing, allow the Consumer Advocate two (2) additional weeks to file its rebuttal, and allow the parties to submit a proposed procedural schedule for approval by the Authority.
