NOTICE OF STRIKE, IN PART, CONSUMER ADVOCATE'S MOTION TO COMPEL

After discussions with representatives of CGC, and a continuing review of this docket, the Consumer Advocate hereby provides this Notice of its intention to withdraw its Motion to Compel with regard to Discovery Requests 52, 53, 54, 63 & 78, from the First Discovery Requests propounded to CGC. The Consumer Advocate maintains its Motion to Compel with regard to all remaining identified requests in the previously filed Motion to Compel.

Thus, there is no need for CGC to respond to the Consumer Advocate's Motion to Compel with regard to Questions 52, 53, 54, 63 & 78, nor will there be a need to present oral argument with regard to these requests at the scheduled hearing on Monday, May 4, 2009. Notwithstanding the above, the Consumer Advocate will pursue its Motion to Compel with respect to Discovery Request 35, from the Third Request for Discovery, propounded to CGC even as it may relate to the ongoing requirement that CGC supplement its responses to the Discovery Requests identified above.
