ORDER GRANTING JOINT REQUEST TO REVISE PROCEDURAL SCHEDULE

This matter came before the Hearing Officer upon a joint request of the parties to revise the Procedural Schedule to allow additional time for the filing of a motion to compel discovery by the Office of the Tennessee Attorney General Consumer Advocate and Protection Division ("Consumer Advocate") and to eliminate a written response to any such motion by the Chattanooga Gas Company ("CGC") received by the Hearing Officer via electronic mail on April 18, 2008. A copy of the electronic mail is attached hereto as Exhibit A.

Pursuant to the Procedural Schedule entered in the docket, any motions to compel concerning the first round of discovery are scheduled to be filed on April 18, 2008, and any responses thereto are scheduled to be filed April 22, 2008. By agreement, the parties have requested that the deadline for filing motions to compel discovery should be rescheduled to April 22, 2008. Further, the provision for any written response to any such motion to compel is to be eliminated from the procedural schedule, with the parties instead agreeing that CGC may opt to provide an oral response during the status conference which had been tentatively scheduled on April 24, 2008. In light of the agreement of the parties and to further encourage a spirit of cooperation, the Hearing Officer hereby agrees to and adopts the revised schedule as proposed by the parties. As further agreed by the parties, the remainder of the Procedural Schedule will not be altered.

IT IS THEREFORE ORDERED THAT:

Any motions to compel concerning the first round of discovery shall be filed no later than **2:00 p.m. on April 22, 2008**. A written response to any such motions shall not be filed; however, an oral response thereto may be offered during the status conference scheduled on April 24, 2008.
