PETITION TO INTERVENE

Stand Energy ("Petitioner") by and through its undersigned counsel, hereby seeks leave to intervene in the above-captioned proceeding pursuant to T.C.A. § 4-5-310 and Tennessee Regulatory Authority ("TRA") Rule 1220-1-2-.08. In support of this petition, Petitioner states as follows:

Stand Energy is an independent marketer of retail energy, including natural gas. Stand Energy competes with Atmos Energy Corporation (Atmos) and/or its affiliate, Atmos Energy Marketing, LLC in Ohio, Virginia, Kentucky and Tennessee. The management and use of Atmos' assets and its gas purchasing practices affect the competitive environment for an independent marketer such as Stand Energy. The determinations in this proceeding may affect Petitioner's legal rights, duties, privileges, immunities, or other legal interests.

Stand Energy was a party in TRA Docket Nos. 05-00258 and 05-00253. Those dockets were closed and Docket No. 07-00225 was opened to address asset management issues pertaining to Atmos. The agency indicated that the parties who

had intervened in the referenced dockets that were closed, would be granted intervention in this docket.


The granting of this Petition will not impair the interest of justice or the orderly and prompt conduct of these proceedings.

Wherefore, the Petitioner respectfully prays that the Authority grant its Petition to Intervene and grant such other relief as may be appropriate.
