ORDER GRANTING PETITION TO INTERVENE

This docket came before the Hearing Officer for consideration of the *Petition to Intervene* filed by Robert E. Cooper, Jr., the Attorney General and Reporter for the State of Tennessee, through the Consumer Advocate and Protection Division of the Office of the Attorney General ("Consumer Advocate").

At the August 20, 2007, Authority Conference, the panel assigned to Docket Nos. 05-00253 and 05-00258 voted to create a new docket as a result of the panel's decisions to close Docket Nos. 05-00253 and 05-00258. The new docket was later assigned Docket No. 07-00225. As part of the decision to open Docket No. 07-00225, the panel voted to allow any party that had participated in either of the two closed dockets to intervene automatically in Docket No. 07-00225.

The Consumer Advocate filed its *Petition to Intervene* in this docket on November 9, 2007. The Consumer Advocate actively participated in Docket No. 05-00258 and, in fact, filed the petition that resulted in the Authority deciding to investigate Atmos Energy Corporation's

earnings as part of Docket No. 05-00258.³ The Consumer Advocate also participated in Docket No. 05-00253 by filing a brief, objections, and comments.⁴ Given the Authority's decisions in Docket Nos. 05-00253 and 05-00258 with regard to automatic interventions and the participation of the Consumer Advocate in both dockets, granting the intervention is automatic. Therefore, there is no need to evaluate the petition pursuant to section 4-5-310 of *Tennessee Code Annotated*.

IT IS THEREFORE ORDERED THAT:

The *Petition to Intervene* filed by Robert E. Cooper, Jr., the Attorney General and Reporter for the State of Tennessee, through the Consumer Advocate and Protection Division of the Office of the Attorney General is granted.
