Pursuant to Section 64.1120 of the Commission's rules, 47 C.F.R. § 64.1120, NuVox Communications, Inc. ("NuVox"), by its counsel, respectfully notifies the Commission that, in furtherance of an internal corporate reorganization undertaken by its parent corporation, NuVox, Inc., NuVox intends to acquire all of the customers of FDN, LLC f/k/a NuVox Transition Subsidiary, LLC ("FDN") and Southern Digital Network, Inc. ("SDN"), existing state operating subsidiaries of NuVox, Inc. NuVox is complying with the Commission's rules and procedures governing compliance with section 258 of the Communications Act of 1934, as amended, including the provision of advanced written notice to all affected customers. In conformity with Commission rules, NuVox provides the following information:

Parties to the Transaction: The parties involved in the transaction are NuVox Communications, Inc. (the acquiring carrier), FDN, LLC f/k/a NuVox Transition Subsidiary, LLC and Southern Digital Network, Inc. All the parties to the transaction are subsidiaries of NuVox, Inc.

Types of Telecommunications Services Provided to the Affected Subscribers: FDN and SDN currently provide competitive local exchange, long distance (domestic and international), and data services to their subscribers. NuVox will provide the same services to these subscribers.

Date of Transfer of the Subscribers to Acquiring Carrier: FDN and SDN intend to transfer all of their subscribers to NuVox on January 1, 2008 or as soon thereafter as all necessary regulatory approvals have been obtained.

Attached to this letter are (a) NuVox's certification of compliance with the requirements of the Commission governing transfers of subscribers, and (b) copies of the notices sent to the affected subscribers, as required under the rules. The customer notices were mailed to the affected customers on November 27, 2007.


