Dear Mr. Roberson:

BE ADVISED that, with this letter, Cinergy Communications Company (hereafter "Cinergy") hereby petitions the Tennessee Regulatory Authority for approval to change its name to Norlight, Inc. (hereafter "Norlight"). We have already changed the name with the Secretary of State's office. Also please note that we have obtained authorization from the Secretary of State's Office to use the assumed name of Cinergy Communications. It is our intent, upon Commission approval, to use the Norlight name to market our enterprise products and to use the name Cinergy Communications to market our residential products.

Cinergy was initially granted authority to provide local and long distance telecommunications services in Tennessee on April 4, 2001, under Docket Number 01-00112. Cinergy's name at the time was Community Telephone Corporation.
