Please accept the original and thirteen (13) copies of this letter as official notification that Working Assets Funding Service, Inc. d/b/a Working Assets Long Distance is changing the assumed name under which it provides telecommunications services in Tennessee to Working Assets Funding Service, Inc. d/b/a Credo Long Distance. The Company was originally certificated to provide Resold Interexchange or Operator Services on September 20, 1995 in Docket No. 95-02846, Certificate No. 00113295.

This is simply a change in Assumed Name and is not the result of a change in control or merger/acquisition activity. This change does not affect the rates, terms or conditions of service currently provided to the Company's Tennessee Customers.

Included with this filing are the Certificate of Assumed Name registration filed with the Tennessee Secretary of State Division of Business Services and a copy of the customer notice. The Company is in the process of updating its surety bond and a copy will be forwarded to your attention as soon as it becomes available.
