
On February 25, 2008, a Telephonic Hearing was held for Wholesale Carrier Services, Inc. in the above-referenced docket.

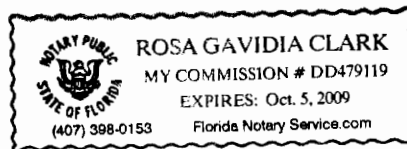
