Dear Chairman Roberson:

On behalf of GoAmerica Relay Services Corp. and its parent, GoAmerica, Inc. (collectively, "GoAmerica"), and Stellar Nordia Services, LLC ("Stellar") this joint filing is made to update and supplement GoAmerica's November 20, 2007 Data Response to Item 5 in the November 14, 2007, letter from Ms. Darlene Standley of the Tennessee Regulatory Authority ("TRA") in Docket No. 07-00205. Pursuant to discussions with TRA Staff, GoAmerica and Stellar would like to repeat and clarify GoAmerica's commitment to assure carrier of choice with respect to any interexchange carrier requested by a Tennessee telecommunications relay service ("TRS") customer, and to affirm Stellar's technical capability to provide carrier of choice with respect to any such interexchange carrier. Please note that a copy of this letter should be filed in each of the above-referenced dockets.

- 5. Descriptions of GoAmerica Relay Services Corp.'s and Stellar Nordia's technical qualifications have focused on IP Relay Services. Please provide a description of GoAmerica Relay Services Corp.'s and Stellar Nordia's technical qualifications specific to wireline/TTY services, including assurance of carrier of choice, true caller ID and SS7 technologies including locations of switches that may be used in a Tennessee relay call.**

A. Clarification of GoAmerica's Commitment to Assure Carrier of Choice in Tennessee

GoAmerica commits to ensure carrier of choice with respect to any interexchange carrier requested by Tennessee TRS customers. GoAmerica acknowledges that, because assurance of carrier of choice is specifically mandated as an obligation of the Contractor

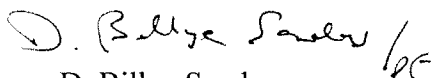
under the Tennessee TRS Contract (see Section A.5.7), GoAmerica is ultimately responsible to ensure that Tennessee TRS customers can access their carriers of choice. Therefore, GoAmerica agrees to do so.

GoAmerica will ensure access to carriers of choice through two contractual arrangements with Verizon. During the transition period from Verizon's network to GoAmerica's network, Verizon will provide certain technical and operational support to GoAmerica pursuant to a Transition Services Agreement (the "TSA") to be executed by the parties at the closing of the transaction. A copy of the TSA was provided **UNDER SEAL** as **Attachment B** to GoAmerica's November 20, 2007 Data Response. Carrier of choice support is specifically included as one of the services to be provided under the TSA (see page 9, item K, of Exhibit A to the TSA). At the conclusion of the transition period, Verizon will continue to provide carrier of choice routing pursuant to a Commercial Services Agreement to be executed directly with Stellar. The Commercial Services Agreement term sheet was provided **UNDER SEAL** as **Attachment E** to GoAmerica's November 20, 2007 Data Response. The last page of the term sheet includes a flow chart diagram of the Tennessee caller of choice arrangement between Verizon and Stellar.

B. Confirmation of Stellar's Technical Ability to Provide Carrier of Choice

Stellar affirms that it has the technical ability to provide carrier of choice routing to any interexchange carrier requested by Tennessee TRS customers.¹ This capability will be enhanced by the technical support of Verizon pursuant to the contractual arrangements outlined above. In addition, as part of the seamless and transparent transition from Verizon's TRS service to GoAmerica's TRS service, Stellar will be able to maintain and use existing customer "profiles," which may include carrier of choice preferences, for all Tennessee TRS customers that have established such profiles.

¹ TRA Staff has expressed concern about the implication in GoAmerica's November 20, 2007 Data Response that Stellar could only connect to a limited number of carriers (see list of 12 carriers on page 3 of **Attachment C** to GoAmerica's November 20, 2007 Data Response). GoAmerica and Stellar would like to clarify that this list is not exclusive; rather, it is a list of the twelve most frequently requested interexchange carriers used by Stellar's customers. Under the terms of the Commercial Services Agreement, Stellar will be able to connect to any interexchange carrier requested by Tennessee TRS customers.
