Ben Lomand Rural Telephone Cooperative, Inc. ("Ben Lomand"), Ben Lomand Communications, Inc. ("BLC Inc.") Volunteer First Services, Inc., ("Vol First Inc."), Ben Lomand Communications, LLC ("BLC LLC") and Volunteer First Services, LLC ("Vol First LLC") by and through their undersigned counsel, files these responses to Tennessee Regulatory Authority ("TRA") Data Request No. 1 dated November 27, 2007.

1. Have the Petitioners filed similar applications or notices in other states? If so, provide a listing of states and action taken.

RESPONSE: No.

2. Have the Petitioners filed a similar petition with the FCC? If so, list any action taken and the associated docket number. If a schedule to complete the review of your petition has been established by the FCC, provide such with your response.

RESPONSE: No. Petitioners are in compliance with FCC Rules.

3. Provide the number of customers that Ben Lomand Rural Telephone Cooperative, Inc., Ben Lomand Communications, Inc., and Volunteer First Services, Inc. currently have in Tennessee.

RESPONSE: Attached hereto is **Confidential and Proprietary** Exhibit A which states the number of customers.

4. Provide a signed verification from the Petitioners stating that the information contained in the *Petition* is true and correct to their best knowledge, information and belief.

RESPONSE: Attached hereto as Exhibit B is the Verification of Levoy Knowles.

5. Explain how the Petitioners will comply with TRA Rule 1220-4-2-.56(2)(d) concerning the transfers of customer base with respect to the transaction described in the *Petition*. In your response, provide a copy of the customer notification letter.

RESPONSE: Attached hereto are Exhibits C and D, the customer notification letters of Ben Lomand Communications, Inc. and Volunteer First Services, Inc., respectively.

The Petitioners hereby request the Authority to waive the thirty day pre-notice due to time constraints and the pro forma nature of the customer transfer. As stated in the Petition, due to tax reasons it is imperative that the restructure be completed before January 1, 2008. No hardship will be caused to the customers because it is not a transfer to a new carrier but merely restructured and renamed Ben Lomand Communications, Inc. and Volunteer First Services, Inc. Petitioners also request that such customer

notification letter be inserted in the first bill to customers after the reorganization is approved and completed. Such mailing will meet the requirements of TRA 1220-4-2-.56(2)(d)(2) because the logo of the current provider will be displayed on the letterhead of the notice and on the exterior envelope of the invoice containing the customer notification letter. Such mailing will save costs and time which will benefit the customers of the companies undergoing the name change. Petitioners submit that such reasons for the thirty day waiver and separate mailing are good cause for waiver under TRA Rule 1220-4-2-.56 (2)(d)(2-4). Furthermore, TRA Rule 1220-1-1-.05(1) provides for waiver of any rules of the Authority. Petitioners ask the Authority to consider the request in this response to be a Motion for Waiver of such rules.

6. Provide a \$20,000 corporate surety bond, irrevocable letter of credit or sufficient documentation to demonstrate compliance with T.C.A. § 65-4-125 for Ben Lomand Communications, LLC; and Volunteer First Services, LLC.

RESPONSE: Attached hereto as Exhibit E is the application and invoice for the surety bond for Volunteer First Services, LLC. The surety bond will be filed upon receipt, which should be during the week of December 3. Vol First, LLC will own and operate equipment facilities in Tennessee with the value of more than five million dollars (\$5,000,000) within the next six to twelve months and thus will meet the exemption requirements of T.C.A. § 65-4-125(j).

Ben Lomand Communications, LLC meets the exemption requirements of T.C.A. § 65-4-125(j) because BLC LLC, upon transfer of assets from BLC Inc., will own and operate equipment facilities in Tennessee with a value of more than five million dollars (\$5,000,000).

7. Will Volunteer First Services, Inc. retain certification to provide telecommunications service after completion of the transaction described in the *Petition?* If not, please explain the basis for requesting approval from the TRA for a name change for a non-certificated entity.

RESPONSE: Volunteer First Services, Inc. will not retain certification to provide telecommunications services after completion of the transactions. Volunteer First Services, LLC will have certification to provide such services after completion of the transactions. Request for approval of the name change was requested out of an abundance of caution. If the TRA is of the opinion that approval is not necessary, then such request for approval of name change is withdrawn. Counsel for Petitioner agrees with the TRA that approval of the name change of Volunteer First Services, Inc. to Ben Lomand Holdings, Inc. is not necessary since Vol First Services, Inc. will not be a certificated telecommunications service provider after the transactions are complete. Therefore, Volunteer First Services, Inc. will be a non-certificated entity when the name change occurs.
