This letter is in response to my discussions with the Utilities Division staff regarding some follow-up questions and data requests for the above-referenced docket.

- 1) The surety bond for Volunteer First Services, LLC has been obtained. A copy is attached as Exhibit A. The original will be filed with the Tennessee Regulatory Authority upon receipt.
- 2) Both Ben Lomand Communications, LLC and Volunteer First Services, LLC have been registered with, and approved by, the Secretary of State. Attached as Exhibit B are the Articles of Organization for both limited liability companies.
- 3) Attached as Exhibit C are profiles of the key management staff for Ben Lomand Rural Telephone Cooperative, Inc. Such staff will hold the same positions in Ben Lomand Communications, LLC and Volunteer First Services, LLC.
- 4) Upon the transfer of assets from Ben Lomand Communications, Inc. to Ben Lomand Communications, LLC, Ben Lomand Communications, Inc. will be dissolved. See attached Exhibit D. The assets of Volunteer First Services, Inc.,

after transfer of its telecommunications services assets, including its Certificate of Convenience & Necessity, will be the stock of Volunteer First Services, LLC and Ben Lomand Communications, LLC.

- As stated in my Response of November 30, 2007 to Data Request No. 1, Ben Lomand Communications, LLC is exempt from the surety bond due to the fact that it will have assets in excess of \$5 million dollars. Such assets will be transferred from Ben Lomand Communications, Inc. Financial information showing such assets of Ben Lomand Communications, Inc. which will be transferred to Ben Lomand Communications, LLC is attached hereto as CONFIDENTIAL & PROPRIETARY EXHIBIT E.
- The customer notification letters submitted in my November 30, 2007 Response have been edited to include the sentence "Please be assured that you will not incur charges related to the transfer of your services to Ben Lomand Communications, LLC (or Volunteer First Services, LLC)." Attached hereto as Exhibits F and G are the customer notification letters with the additional sentence in bold clarifying that the customers will not be charged for the transfer of services.
- 7) I have verified that no "FCC 00-257" letter is required. Petitioners' Washington, D.C. legal counsel have opined that no carrier change notification (FCC Docket No. 00-257) is required by the FCC under the factual circumstances attendant to the planned corporate reorganization.

My clients and I greatly appreciate the efforts of the Tennessee Regulatory Authority staff in expediting this petition.


