- 1) Provide an intraLATA toll dialing parity plan for Bandwidth.com CLEC, LLC that is consistent with FCC 96-333.
- 2) Provide pre-filed testimony regarding the managerial, technical and financial capability of Bandwidth.com CLEC, LLC.
- 4) Please provide a \$20,000 corporate surety bond or irrevocable letter of credit. This bond or letter of credit will be verified by the Authority prior to consideration for authority.
- 5) Provide a Small and Minority Owned Business Participation Plan that is compliant with Tenn. Code Ann. § 65-5-112.
- 6) Explain how Bandwidth.com CLEC, LLC will comply, technically, with Tenn. Code Ann. § 65-21-114.

- 7) Provide a notice of filing of this application to all eighteen (18) Incumbent Local Exchange Carriers in Tennessee.
- 8) Provide an informational tariff setting forth the rates, terms and conditions of services to be offered by Bandwidth.com CLEC, LLC.

Please provide the above information by January 24, 2008. In accordance with TRA Rules, please submit either (1) thirteen written copies of your response or (2) four written copies and an electronic version and reference docket number 07-00256 on the correspondence.
