This matter came before Chairman Eddie Roberson, Director Sara Kyle and Director Ron Jones of the Tennessee Regulatory Authority (the "Authority"), the voting panel assigned to this docket, at a regularly scheduled Authority Conference held on December 17, 2007 for consideration of the Application of Deer Run Property Management, Inc. d/b/a Deer Run RV Resort to be an operator of Customer Owned Coin or Coinless Operated Telephone ("COCOT") service in the State of Tennessee filed on November 27, 2007.


IT IS THEREFORE ORDERED THAT:
