- 5. Concerning TRA Rule 1220-4-2-.56(2)(d)(4), please explain how the customer notice in Exhibit B of the *Petition* informs transferred customers that they will receive a thirty-day written notice of any rate increase that may affect their service up to ninety days from the date of the transfer.
- 6. As required by FCC Rules in CC Docket No. 00-257, provide a copy of the self-certification letter filed with the FCC regarding customer transfers.
- 7. Concerning the assumption of the fictitious name "Least Cost Routing" as described in the *Petition*, please provide information as required by TRA Rule 1220-4-1-.08.
