Organizational Charts

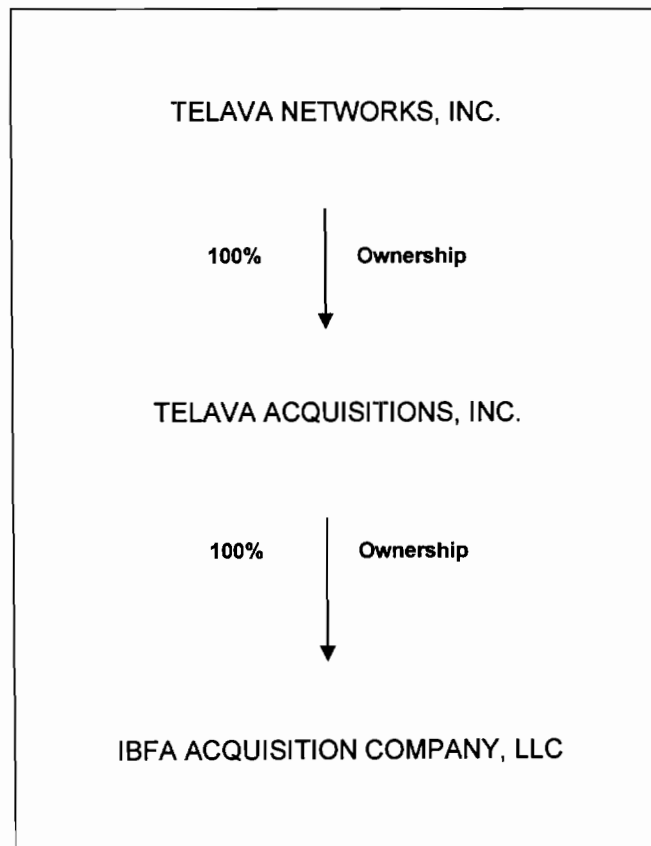
Relationship between Utility and Acquirer prior to Transfer
