- 1) Has XO Communications Services, Inc. ("XOCS") filed similar petitions or notices in other states? If so, provide a listing of states and action taken.

Answer: Yes, XOCS has filed similar petitions in the following states: Arizona, Delaware, Georgia, Hawaii, New Jersey, New York and West Virginia. These petitions currently are pending.
