Surrender of Certificate of Public Convenience and Necessity

Dear Chairman Morrison:

On behalf of Crown Castle Fiber LLC ("Crown Castle Fiber"), as the successor-in-interest to Access Fiber Group, Inc. ("AFG"), this letter surrenders the Certificate of Public Convenience and Necessity ("CCN") of AFG granted in Docket No. 08-00044. The surrender of AFG's CCN is made in connection with the *Pro Forma* Consolidation that was completed on December 31, 2018, and described in the Notice filed in Docket No. 18-00118. As a result of the *Pro Forma* Consolidation, effective January 1, 2019, AFG no longer exists as a separate entity and all assets, contracts and property of AFG are now owned by Crown Castle Fiber, which operates in Tennessee pursuant to the CCN granted in Docket No. 13-00117 and transferred to Crown Castle Fiber. *See* Docket No. 18-00118. Since AFG no longer exists as a separate entity and Crown Castle Fiber provides services to AFG's customers, AFG's CCN should be cancelled effective January 1, 2019, as soon as the Commission can take any appropriate administrative action.

Crown Castle Fiber submits that the public will not be harmed by the surrender (and cancellation by the Commission) of the CCN of AFG, and that such surrender is reasonable and necessary and not disruptive to the present or future public interest, convenience and necessity.
