Dear Mr. Steinhart:

CLEC applicants are required, by statute, to demonstrate their managerial, financial and technical abilities to provide the services for which they seek authority. To assist the Authority in its review of Prayztel Communications, LLC's application for Certificate of Convenience and Necessity to provide competing local exchange and long distance telecommunications services in Tennessee, you are requested to provide the following information:

- 1) Provide a direct telephone and facsimile number for Mr. Mark Goldsmith. The telephone number provided in the application is the toll free customer service number, and no facsimile number was provided.
- 2) Provide a signed original Surety Bond in the amount of \$20,000 pursuant to Tenn. Code Ann. § 65-4-125(j). The Surety Bond provided was not an original, nor was it signed by the Principal on page 2 of the bond.
- 3) Provide more detailed information as to the managerial and technical qualifications of the principal officers including, but not limited to, educational background and degrees earned; detailed work history, including employer names and addresses, titles/positions held, duties and responsibilities, dates of employment and supervisor names and contact information; and a description of relevant telecommunications and business experience and applicable skills. Additionally, a detailed description of the current duties and responsibilities of each officer and all key management personnel of Prayztel must be included.
- 4) Will Prayztel rely on its underlying carriers for technical support or is there an officer or staff member with expertise in this area? Provide further details regarding technical capability.

- Provide evidence to support the Assets listed on the Balance Sheet dated March 13, 2008. Detail how these assets were acquired. Are there additional sources of funding available to Prayztel? If so, provide evidence of these sources of funding.
- 6) Provide further information regarding the technical qualifications of Prayztel's Chief Technology Officer, Mr. Lieberman.
- 7) Explain, technically, how Prayztel's current billing system will allow it to bill the calling plan in compliance with Tenn. Code Ann. § 65-21-114, as stated in the application.

Please provide the above information by April 28, 2008. In accordance with TRA Rules, please submit either (1) thirteen written copies of your response or (2) four written copies and an electronic version and reference docket number 08-00049 on the correspondence.
