- 3) Is Prayztel Communications, LLC affiliated in any way with Talkspan, the company owned and operated by Mr. Liebermann? If so, detail the affiliation.
- 4) Is Prayztel Communications, LLC affiliated in any way with the Church of God in Christ, Inc.? If so, detail the affiliation.
- 5) Is Prayztel Communications, LLC affiliated with Glick Holdings, LLC? If so, detail the affiliation.

- 6) Is Prayztel Communications, LLC affiliated with HLG Telco, LLC? If so, detail the affiliation.
- 7) Is Prayztel Communications, LLC affiliated with MC-PZT, LLC? If so, detail the affiliation.

Please provide the above information by May 12, 2008.
