What position/title does Mr. John Lieberman hold with Prayztel Communications, LLC? Detail his duties and responsibilities for Prayztel's Tennessee operations
- 2) Provide Prayztel Communications, LLC's Articles of Organization.
- 3) Is Prayztel Communications, LLC affiliated in any way with Talkspan, the company owned and operated by Mr. Liebermann? If so, detail the affiliation.
- 4) Is Prayztel Communications, LLC affiliated in any way with the Church of God in Christ, Inc.? If so, detail the affiliation.
- 5) Is Prayztel Communications, LLC affiliated with Glick Holdings, LLC? If so, detail the affiliation.

- 6) Is Prayzel Communications, LLC affiliated with HLG Telco, LLC? If so, detail the affiliation.
- 7) Is Prayzel Communications, LLC affiliated with MC-PZT, LLC? If so, detail the affiliation.

Please provide the above information by May 12, 2008. In accordance with TRA Rules, please submit either (1) thirteen written copies of your response or (2) four written copies and an electronic version and reference docket number 08-00049 on the correspondence.
